Program Disclosure

Requirements

The Capella University Master of Science in Clinical Psychology degree program with a specialization in Clinical Counseling (MS CPCC) does not require students, trainees, and/or staff (faculty) to comply with specific policies or practices related to the institution's affiliation or purpose.

Such policies or practices may include, but are not limited to, admissions, hiring, retention policies, and/or requirements for completion that express mission and values.

Program Options

The program is delivered primarily through distance education. Didactic courses are delivered via online Canvas courserooms. The program includes in-person requirements for residencies, practicum, and internships. Thus, the program is delivered in a hybrid model.

Resources and Facilities

Capella University offers resources and support for students that can be seen on the [Student Support Services](#) page of the Capella website.

Academic support includes the writing center, online library, and tutoring from subject matter experts. Financial support includes assistance with the financial aid process, and scholarships and other cost-saving opportunities. Career support is offered through resume help, interview prep, an employer database of job listings, one-on-one career coaching, a student and alumni networking platform to connect with students and alumni in the field, and quarterly career development events, webinars and workshops. Personal support is offered through disability services, military support, student communities, peer-to-peer mentoring, 24/7 tech support, and an alumni association.

Minimum technology requirements include a broadband internet connection with 512kbps upload and download speed, word processing application to save and open Microsoft Office format, Adobe Acrobat Reader to view PDF files, and anti-virus software to scan files and emails. Faculty-Student Ratio

The MS CPCC program has 9 full-time faculty and 17 part-time faculty for a total full-time faculty equivalent of 14.67. The program has 305 full-time equivalent students, for a full-time faculty equivalent to full-time student equivalent ratio of 1:20.79.

Type(s) of clinical training provided

As described in the program handbook, as well as on Campus, students are required to complete two residency courses that include in-person experiences, as well as a practicum and an internship.

The residency experiences are in person and located at a facility chosen by Capella faculty. This may require students to travel to the chosen residency location. While Capella identifies locations for residencies, students can select the residency quarter/location that works best for them, as long as it aligns with the student course sequence.

Capella site-based learning specialists work closely with faculty, external stakeholders, and students in programs with on-site practicums and internships.

To successfully complete the practicum, students will be expected to:

1. Apply current theory, research and best practices at practicum, in the areas of ethical practice and compliance with law.
2. Apply current theory, research and best practices regarding diversity and cultural sensitivity at practicum.
3. Apply professional standards, ethics codes, and laws to behavior with colleagues, professionals, and supervisor.
4. Apply current theory, research and best practices to professional activities (such as assessments and interventions) conducted at practicum.
5. Communicate in a manner that is scholarly, professional, and consistent with expectations for members of the psychological professions.

To successfully complete the internship, students will be expected to:

1. Apply current theory, research, and best practices to professional activities conducted during internship (such as assessments and interventions).
2. Evaluate practice decisions made by self and others consistent with ethical models, professional standards, and laws.
3. Synthesize self-reflections that include feedback from others, insights, key learning moments and decisions, changes in thoughts and attitudes, strengths, and areas for ongoing professional development.

4. Apply current research and best practices in consideration of diversity and cultural sensitivity.
5. Communicate in a manner that is scholarly, professional, and consistent with expectations for members of the psychological professions.

Graduation requirements

To complete the program and meet the requirements to graduate, students must successfully complete:

- 74 quarter credits
- two residencies
- one practicum
- one internship

Admissions Criteria

As stated in the [Capella Admission's Policy](#), applicants to the MS in Clinical Psychology, Clinical Counseling specialization “are required to submit a degree-conferred transcript for a bachelor’s degree as well as transcripts from all previous institutions at which graduate work was completed (minimum degree-conferred GPA of 2.7 for undergraduate work and 3.0 cumulative GPA for related graduate work). Applicants will also be assessed on professionalism and academic fit to the program as determined by the school.”

Learners may transfer a maximum of 20 quarter credits toward the MS degree. Transferred credits do not impact the time to completion. Per [APA accreditation standards](#), the program requires students to complete a minimum of 2 academic years (or the equivalent thereof).
